



1. Terms and Conditions

(a) You are entering into a transaction (the **Transaction**) with Success Resources Australia PTY LTD (herein after referred to as 'SRA') to purchase a private event known as the 'Kiyosaki Live, entitling you to the inclusions set out in section 3 below.

(b) By proceeding with the Transaction and making a payment, you confirm that you:

(i) have read, understood, and agree to these terms and conditions.

(ii) agree to the privacy policy of SRA – <https://success-resources.com.au/privacy-policy.html>

(iii) agree to the conditions of entry set by the venue at which the Kiyosaki Live will take place, being Royal Randwick Racecourse

(iv) acknowledge and understand it is incumbent upon you to provide SRA with full and accurate details of each attendee as required under section 4, failing which you may not receive the benefits to which you may otherwise be entitled.

(v) agree that whilst the advertised line up & agenda is correct at release, it is subject to change without notice and that you will have no claim against SRA either for a refund or for any other claim whatsoever.

(vi) Understand that Kiyosaki Live is a private live seminar for people looking to create multiple streams of income and improve their business strategy, hosted by SRA. During Kiyosaki Live, as well as being provided with training and other content, attendees will be given the opportunity to purchase further training and services they may find valuable. 2. Payment

(a) You agree:

(i) to pay SRA in full, when placing an order to purchase Kiyosaki Live.

(ii) until payment has been completed in full, you will not be entitled (nor able) to receive any of the inclusions associated with your purchase of Kiyosaki Live.

(b) All pricing is in Australian Dollars and includes local taxes.

3. Kiyosaki Live Inclusions

(iii) Digital Tool kit delivered after attending Kiyosaki Live

(iv) Diamond ticket holders only will have a 1 on 1 photo with Robert Kiyosaki

4. Requirements of Purchase

(a) A name, contact number & unique email address will be required for the purchase of Kiyosaki Live.

(b) All tickets purchased for Kiyosaki Live will be sent to the buyer who will then be responsible for forwarding the tickets to their guests/attendees.

(c) When entering the [ICC Sydney](#) photo identification may be requested & must match the name on the ticket to guarantee entry.

5. Cancellation Rights

- (a) Note that there is no cooling-off period and payment for a Transaction is not refundable.
- (b) If Kiyosaki Live is postponed for any reason, your inclusions will apply to the rescheduled event. A rescheduled event will be provided to you before 14th of March 2025.
- (c) If Kiyosaki Live is cancelled for any reason, you will be entitled to a refund of the Kiyosaki Live purchase but will have no other claim of any nature arising out of such cancellation.
- (d) Inclusions not used are not able to be swapped or exchanged for credit.
- (e) If you purchase Kiyosaki Live via the telephone, you will have 10 business days from the date of purchase to cancel your purchase & obtain a full refund. Requests must be made in writing to info.au@srglobal.com for a refund to be considered.
- (f) Should you qualify for a refund, the amount will be refunded within 30 business days from cancellation.

6. Kiyosaki Live Resale

- (a) The re-advertisement or re-sale of Kiyosaki Live inclusions is strictly forbidden.
- (b) If any inclusions of Kiyosaki Live are found to be re-advertised or for re-sale SRA reserves the right to cancel all inclusions with no refund provided.
- (c) Only purchases made directly through SRA for Kiyosaki Live will be guaranteed access to the inclusions listed in section 3.

Scalping warning: The resale of inclusions in certain circumstances is governed by ticket sales legislation and may attract criminal penalties.

7. Force Majeure

- (a) If Kiyosaki Live has to be re-scheduled, postponed or cancelled as a result of an act of God, Government legislation, public health orders, an inevitable accident, power cut, fire, blackout, flood, COVID-19, pandemic, injury, death or any other calamity, or if by reason of strikes, or lockouts, or any other events beyond the direct control of either party, SRA reserves the right to postpone and reschedule Kiyosaki Live and the provisions of section 5(b) or 5(c), as the case may be, will apply.
- (b) SRA reserves the right to alter the venue, speakers and amend the agenda due to circumstances outside of its control.
- (c) SRA will not be liable in any manner whatsoever for any cancellation or postponement of the Kiyosaki Live because of Force Majeure or a change of venue or amendment to the agenda arising out of this clause 7.

8. Privacy and your security:

- (a) SRA will collect personal information including but not limited to name, contact details, email address and postal address. This information will only be shared with approved partners to provide access to Kiyosaki Live and enhance your Kiyosaki Live experience.
- (b) You acknowledge and agree that SRA may disclose and use your personal information in accordance with the SRA privacy policy available at <https://success-resources.com.au/privacy-policy.html>
- (c) Should you not wish to appear in any promotional or marketing materials you must notify us via info.au@srglobal.com before the date of Kiyosaki Live.

9. Filming:

- (a) You acknowledge and agree that portions of the Kiyosaki Live may be recorded, and that SRA shall own any recordings that can be used at their discretion for promotional or marketing purposes.
- (b) You agree not to record any part of Kiyosaki Live. Failure to comply with this directive could lead to your participation in Kiyosaki Live being revoked with no refund or credit being provided.
- (c) You may not use recordings from Kiyosaki Live for commercial purposes without the prior written consent of SRA which may be withheld in our absolute discretion.
- (d) Without derogating from the above, materials distributed by SRA as part of Kiyosaki Live may not be distributed or re-produced.

10. Kiyosaki Live Information

- (a) All notices or other communications must be made to info.au@srglobal.com
- (b) to prevent exposure to possible adult themes and/or use of adult language (including obscenities) we recommend that persons under age 16 do not attend Kiyosaki Live.

- (c) Attendance by children aged 11-16 is only with parent or guardian discretion on the provision that they have a valid ticket and are always accompanied by an adult. Under 10's are not permitted to attend Kiyosaki Live.
- (d) All event content is in English, and no translation is provided.
- (e) Speakers will appear at different times and not the full duration of Kiyosaki Live.
- (f) One invoice is generated per order and communication is solely with the buyer of Kiyosaki Live.
- (g) Tickets will be emailed out approximately 2 weeks prior to Kiyosaki Live start date.
- (h) If you have any special access requirements, please email info.au@srglobal.com with your requirements.
- (i) Tickets to Kiyosaki Live are unable to be transferred to an alternative date or services offered by SRA.
- (j) All attendees must act and behave in a respectful way to fellow attendees, staff, and speakers. Failure to do so may result in removal from Kiyosaki Live without a refund provided.
- (k) Dress code is smart casual. Any inappropriately dressed attendee may be refused access to Kiyosaki Live with no refund provided.
